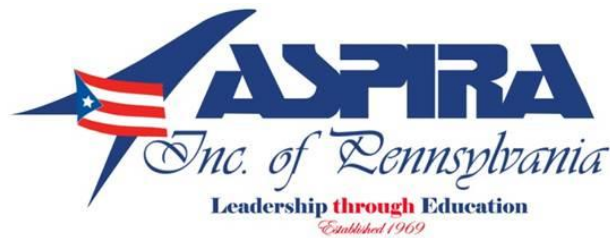


# 2018 ASPIRA Hostos Coqui and SOL Camp Registration Packet



## Important Registration Information:

- Applications are NOT processed on a first come, first served basis.
- Registration packets must be complete or will not be accepted. Up to date Health Assessment is a MUST
- No down payment is necessary. If your child is accepted to our summer camp, in the acceptance letter there will be a date when all final payments are due

## 2018 Summer Camp Fees

### Coqui Camp (K-5<sup>th</sup>)

- Regular (6 weeks) – M-F (8-4:00 pm) - \$375 (\$25 discount for one additional sibling)
- ASPIRA Employee - \$270 (\$20 Discount for one Additional Sibling)

### SOL Camp (middle school)

- Regular/Employee– M-F (8:00-4:00pm) - \$270 per child

### ASPIRA Career Explorations

- Regular/ASPIRA (6 weeks) – M-Th. Times TBA – No Fee for Program

### CAMP POLICIES:

- A current Program application is required for every child in Camp.
- Full payment is Due Prior to Start of Camp

- Any child picked up after 4:00PM will receive a \$1.00 late fee per minute, fees must be paid before they return to the camp program.
- All medical forms MUST be on file before your child can begin summer camp.
- I understand my child will only be released to those individuals listed on the emergency contact/parental consent form. Valid photo identification – driver's license must be presented at pick up. Person picking up child has to be 18 years of age and older.
- I understand that a custody order must be on file at the program if one or more parent does not have visitation rights. A custody order cannot be enforced if ASPIRA Children, Youth, and Family Services does not have a copy of the order on file.
- All electronics, games, cell phones and any other item of value will not be brought to camp. I understand the ASPIRA Summer Camp staff will collect and store equipment, but will not be held responsible for lost, broken, or stolen items.

By signing below, I acknowledge that I have received the Parent Handbook and consent to ASPIRA Camps enforcing all of the policies and procedures stated therein. No child will be admitted into camp until all paperwork is completed and returned to the ASPIRA. I have retained a copy for my records.
